

COVID-19: Devolved Administrations

The Chancellor has clarified that as part of additional measures to tackle the coronavirus outbreak, devolved administrations will receive at least £3.5bn in funding to support businesses in Scotland, Wales and Northern Ireland. All UK businesses can access the [Coronavirus Job Retention Scheme](#), reclaiming Statutory Sick Pay, the [Business Interruption Loan Scheme](#), VAT deferrals and the HMRC Time to Pay service. Wales



Business Rates Holiday

In Wales, retail, leisure and hospitality businesses irrespective of their rateable value will receive 100% rates relief in 2020-21. This will be administered through the business rates system. You do not need to do anything. Your local authority will contact you.

Cash Grants

Businesses in Wales that receive Small Business Rates Relief will receive a cash grant of £10,000. Retail, leisure and hospitality businesses with a rateable value between £12,001 and £51,000 will receive a cash grant of £25,000. Businesses do not need to do anything to apply for the grant, it will be administered through the business rates systems. Local authorities will be in contact with businesses.

New Small Business Grant

The Welsh Government will also be setting up a new small business grant. Details about how to apply will be made available shortly.

Scotland



Business Rates Holiday

Retail, leisure and hospitality businesses will receive 100% rates relief for 12 months.

Business Rates Relief

There will be 1.6% rates relief for all properties across Scotland, effectively reversing the planned below inflation uplift in the poundage from 1st April 2020. Businesses do not need to apply for this relief as it will be applied to their bill by the local council.

Cash Grants

Businesses which benefit from the Small Business Bonus Scheme or Rural Relief will be entitled to a one-off £10,000 cash grant. £25,000 cash grants will be offered to retail, leisure and hospitality businesses with a rateable value between £18,000 and £51,000. The Scottish Government have yet to provide any information about how to access these grants. However, businesses will be required to apply and will be able to do so from April 2020 to 31 March 2021.

Critical Workers

The Scottish Government has given [guidance](#) to local authorities about defining 'key workers' to enable them to continue sending their children to school in order to work. This includes workers 'supporting our Critical National Infrastructure' and 'all workers without whom there could be a significant impact on Scotland'. Local authorities will make their own definitions so please check your council website.

Northern Ireland



Business Rates Holiday

All businesses will pay zero rates for the next three months (May, June, July). For more information, click [here](#).

Cash Grants

A cash grant of £10,000 will be made available to all small businesses who are eligible for the Small Business Rate Relief Scheme and a grant of £25,000 to be made available to businesses in the hospitality, tourism and retail sectors with a rateable value from £15,000 up to £51,000.
